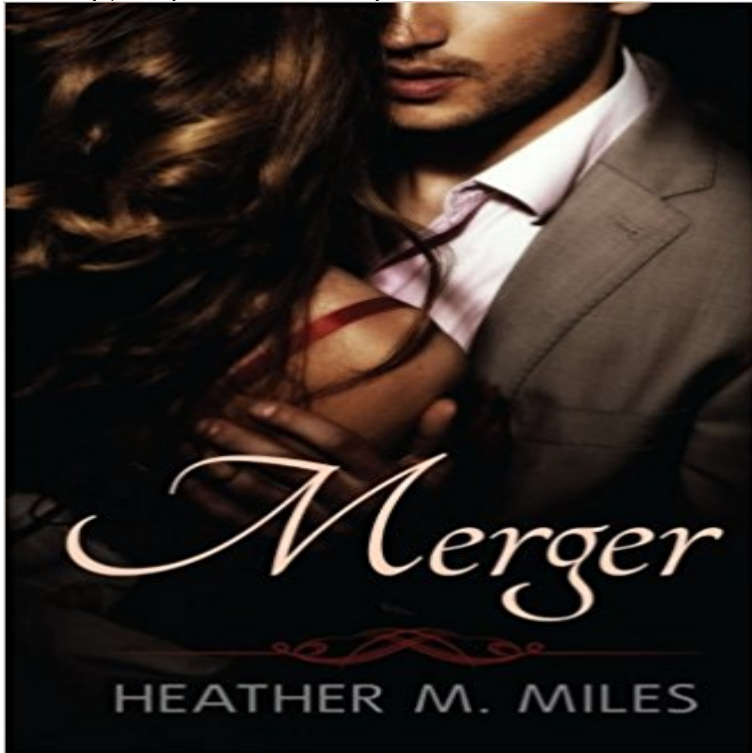


Merger (Volume 1)
